



Questionnaire: MicroStar - Konvoy

The Australian Competition and Consumer Commission (**ACCC**) is currently assessing MicroStar Logistics LLC's (**MicroStar**) proposed acquisition of certain assets of Konvoy Holdings Pty Ltd (Receivers and Managers Appointed) (**Konvoy**) (the **Acquisition**).

The ACCC is assessing the impact of the Acquisition on competition and is seeking your views. The ACCC invites you to provide submissions or information in response to the questions below by **16 February 2026** via email to mergers@acc.gov.au with the title *Submission re: MicroStar - Konvoy*. The ACCC must complete its assessment within strict statutory timelines which also impacts the time available for consultation.

Questions

In this questionnaire:

Keg pooling services refers to a service in which customers can rent a keg for a single fill. When the keg is emptied, the empty keg is then collected by the keg rental company, which can then rent the keg out to another customer.

1. Provide a brief description of your business or organisation, including any commercial relationships with MicroStar or Konvoy.

2. Outline any concerns you have regarding the impact of the Acquisition on competition.

Questions for customers of MicroStar or Konvoy

3. In the event that you were not able to access keg pooling services or the price for keg pooling services increased substantially, what impact would this have on your business? How would you respond? What options are available?

4. In the last six (6) months, have you experienced any changes (in terms of price, or quality or nature of services) to the supply of keg pooling services or keg leasing services you access from MicroStar or Konvoy? If so, please provide details on the nature of those changes.

Questions for competitors or potential competitors of MicroStar or Konvoy

5. Does your organisation compete with MicroStar or Konvoy in their supply of key pooling services? If so, describe the services you supply in competition with them. If not, is your organisation interested in providing keg pooling services, why/why not?

6. Please describe what is involved in entering and expanding in the supply of keg pooling services. If known, please provide details on the assets and supporting facilities necessary to enter or expand. Do you consider that the Acquisition will change the ease or difficulty of commencing the supply of key pooling services?

Other issues

7. Provide any additional information or comments that you consider relevant to the ACCC's assessment of the Acquisition.

Confidentiality of responses

During the ACCC's assessment of a notified acquisition, the ACCC may receive information that is properly regarded as being confidential, and which is provided to the ACCC in confidence. The ACCC is committed to treating this information responsibly and in accordance with the law. The ACCC understands the importance of confidentiality to parties involved in a notified acquisition, as well as to third parties that provide information to the ACCC.

The standard terms on which the ACCC accepts confidential information are:

- there is no restriction on the internal use, including future use, that the ACCC may make of the confidential information consistent with the ACCC's statutory functions
- confidential information may be disclosed to the ACCC's external advisors and consultants on condition that each such advisor or consultant will be informed of the obligation to treat the information as confidential, and
- the ACCC may disclose the confidential information to other third parties if compelled by law or in accordance with section 155AAA of the Act. This includes disclosures made in the performance of official duties or functions, which include transparency requirements which are part of the merger control regime.
